FROM THE PRESIDENT & CEO

Co-op will return more than \$932,000 to consumers

I AM PLEASED to

announce that Valley Rural Electric Cooperative will be returning more than \$932,000 in capital credits this year to eligible members and former members of the cooperative.

If you get your electric service from a cooperative, you are essentially a partowner of the business. As an owner, you are entitled

to any returns on your investment, based on the amount of electricity you used during the year. The capital credits checks you receive are a partial refund of your contribution. At Valley REC, we are proud to be able to return these funds — evidence that we are in a sound financial position.

For the sixth year in a row, the cooperative will use a combination of two methods to retire capital credits.

The first-in/first-out method will be used to retire funds remaining from 1983, which amount to more than \$541,000. This approach enables the co-op to return money to members who have invested for the longest time.

The percentage method will be used to refund capital allocated after that time, amounting to about \$206,000. This ensures that present-day members who are paying for current costs

are still rewarded for their patronage of the cooperative.

In addition, more than \$185,000 will be earmarked for distribution to the estates of deceased members, allowing those accounts to be retired on a discounted basis.

Including this year's refund, we have returned nearly \$16 million in capital credits to our consumers over the years.

Unlike private power companies or other stock-funded corporations, a cooperative is fully owned by its members. That means folks like you have input on how the business is run through an elected board of directors chosen from the membership. If there is revenue in excess of expenses, commonly referred to as margins, the board allocates those monies back to the consumers.

Your representatives on the Valley REC board of directors are confident that the co-op is in a secure position to sustain its rate of capital credits retirement while maintaining its fiscal stability.

Valley REC does not exist to make a profit, but rather to provide safe, dependable electricity at the lowest possible cost. Our "not-for-profit" status proves that point. For nearly 70 years, we have reinvested in our communities, and have given local folks the power they need to live rural life to the fullest.



RR 1, Box 502 Martinsburg, PA 16662-9610



Over the next 12 years, Phil held various positions. He drove a school bus for Smith Busing of Roaring Spring. He operated equipment for New Enterprise Stone and Lime Co. and PennDOT. And he drove tour buses for several companies, traveling throughout the United States and Canada. Since October 2006, he has been providing transportation for local Mennonite families.

A 1956 graduate of Morrisons Cove High School, Phil is a member of the Curryville Church of the Brethren, where he has served as a deacon and board member. He is a former member of the Martinsburg Volunteer Fire Co., the Blair County Farmers Association and Interstate Milk Producers cooperative (now Land O'Lakes). He served three years in the U.S. Air Force, and was honorably discharged as an airman second class.

Mervin Brumbaugh has served on the Valley REC board of directors since 1972. He has held the office of vice chairman of the board two times for a total of five years.

The owner of a 190-acre farm, Merv rents out 100 acres and farms 40. He raises 20 head of beef cattle and 600-700 laying hens, delivering eggs to 40 customers. In addition, he has operated a cattle-hauling business for the past 15 years.

A 1954 graduate of Williamsburg High School, Merv is a member of the Heritage Baptist Church in Martinsburg. He serves as a director of the Williamsburg Farm Show Association and is a former member of the Williamsburg Young Farmers Association. Since 1995, the Brumbaugh property has been the site of a hymn sing, open to the public, during the last weekend in July.
