LETTER FROM THE President



It is indeed my pleasure to report on the status of your electric cooperative. I consider it an honor and privilege to have been selected by your board of directors to succeed Edward Dezich as president and CEO of Valley Rural Electric.

This report will highlight the cooperative's achievements during 2008. Thanks to Ed's leadership and the hard work and dedication of your employees, Valley continues on a successful path of maintaining a strong financial position while providing its members with reliable service at reasonable rates.

Our search for a new location for the Huntingdon district operations ended in May 2008 when we purchased the former Shaner Energy building at the intersection of Fairgrounds and Station roads south of Huntingdon. A 12,000 square-foot truck garage/warehouse was added to the site. The district office is now more centralized within its service territory and our line crews have easy access to two main travel arteries, routes 22 and 26 (south). The old facility along Standing Stone Road will be sold.

Keeping trees properly trimmed along Valley's 2,900 miles of electric distribution line represents one of our most challenging and costly maintenance programs. More than 61 percent (\$1,536,000) of our 2008 maintenance budget was spent on tree trimming. Valley's five-year right-of-way maintenance cycle helps the co-op minimize costly and inconvenient outages and allows our distribution system to operate more efficiently because energy losses are reduced. In fact, we estimate that this program saves members more than \$350,000 annually in wholesale power costs.

A complete distribution system inventory project began in 2008. It is expected to take between 18 months and two years to complete and will provide our personnel with an accurate, electronic database as well as digitized maps of Valley's system. To compliment this new mapping system, our employees who design, upgrade and expand our power line paths will soon use an electronic, automated staking system. This will dramatically streamline our record-keeping processes.

Cooperative personnel completed work on several system improvement projects in 2008. The operating voltage for the lines between our Riverview Substation (along Route 103 near Mount Union) and our Three Springs Substation (on Route 994 between

Three Springs and Orbisonia) was upgraded from 12,500 to 25,000 volts. The higher voltage reduces line losses and doubles the load capacity, enhancing our ability to transfer load between the two subs in maintenance and outage situations.

Three-phase voltage regulator banks were installed at several locations on Valley's system. They improve voltage levels in the area during times of heavy electrical load or when load must be transferred between adjacent subs. The first bank is located at the intersection of routes 26 and 994 near Entriken. The second is on a circuit in Blair County between our Sinking Valley and Frankstown subs, and the third is installed in Franklin County near Fannettsburg. Numerous other small-scale line improvement projects have also been completed throughout the co-op's eight-county service territory.

Total energy sales for 2008 were 275,252,759 kilowatt hours (kWh), up 1.2 percent from the previous year. However, even with this slight increase, sales have been relatively flat for the past four years. Unfortunately, our costs to upgrade, operate and maintain the co-op's electric distribution system have increased nearly 19 percent since 2005. Global demand has forced up costs for line materials and equipment. The current economic recession has eased skyrocketing prices somewhat, but we anticipate that the relief will be temporary.

We continually strive to control our costs by managing expenses and incorporating technology and efficiencies where possible. We are also committed to providing reliable service throughout our rural service territory. To ensure we continue to achieve this goal, system maintenance programs must be carried out and investments need to be made to rebuild and upgrade the system. While the decision was not an easy one, your board has chosen to implement a rate increase in July. Residential, seasonal and small commercial accounts will see a \$6 increase in the basic monthly charge. The base charge for medium and large commercial accounts will go up \$12. This is about a five percent increase for most members.

We at Valley Rural Electric work hard to anticipate any potential issues that could escalate the costs of energy and we try to minimize their impact on your electric bills. We have programs and services in place to help you use electricity more wisely. We're also here to listen to your concerns and answer any questions.

LETTER FROM THE Chairman



On behalf of your board of directors, I am pleased to give an account for the accomplishments and goals of the cooperative in 2008.

Like myself, you have the privilege of being a member (and part-owner) of a financially sound utility. We've been able to maintain a strong percentage of member equity as recommended in our equity management plan. At the end of calendar year 2008, co-op equity was at 41.4 percent of assets. The extensive retail rate study that was performed about two years ago was based on a 10-year financial plan, which helped us determine an ideal equity range for the co-op.

As we have done each year for more than two decades, the cooperative plans to return capital credits to its members in 2009. However, there will be two significant changes to note regarding the distribution of this money.

First, the board has decided that, in order to better manage cash flow and save thousands of dollars in interest expenses, capital credits will now be returned at the end of the year instead of in April. After careful consideration, it was determined that this method would result in the most significant savings for the cooperative. Also, by applying capital credits in December, we hope to help offset the higher bills you typically experience around the holidays.

Secondly, the money will appear as a bill credit on your primary electric account. Of course, former members will still receive a check. This change will help the cooperative save greatly on processing time and postage costs.

The financial stability of our co-op shows in our ability to retire capital credits, support operations and maintain equity while satisfying the requirements of our lenders -- the Rural Utilities Service and the National Rural Utilities Cooperative Finance Corporation.

I mentioned in my report last year that board members and co-op management staff had conducted a strategic planning session geared toward key goals for the next several years. Implementing new and updated technologies was one of those goals. There are now several technology projects underway that should significantly improve the way we do business.

We have already begun to plan for updating our present load management system, which is used to turn off electric water heaters during periods of peak demand. The new equipment will allow the co-op to take advantage of the latest innovations in demand-side management. Demand response is an important resource to use in controlling electric rates because it reduces the need for new generating capacity and cuts down on costly demand charges. We will offer more details on the upcoming load management project through the co-op's website and publications.

Another goal was to provide more efficient ways for members to report meter readings. Members can now key in meter readings via the co-op website (www.valleyrec.com) or by using a touch-tone phone. These two features help us bridge the gap until we begin integrating an automated meter reading system in the years ahead that will eliminate the need to turn in readings.

Speaking of website features, by the end of 2009, we plan to include online bill payment options and access to account history. The site already offers an online energy audit program where visitors can get energy efficiency information tailored specifically to their homes.

Your directors are responsible for the oversight of a corporation with a total utility plant of nearly \$81 million. That's why we place an emphasis on training and development. All directors have obtained Credentialed Cooperative Director Certification. In addition, three directors have received NRECA Board Leadership Certification.

Co-op employees hold themselves to a high standard as well. In fact, thanks to their commitment, the co-op recently earned an "excellent" rating during safety re-accreditation from the National Rural Electric Cooperative Association.

In conclusion, your board is confident that the co-op is in a healthy financial position. We take very seriously our responsibility to continue that record of success. Thank you for allowing us to serve.


