

EXECUTIVE REPORT



N BEHALF OF the board of directors and employees at Valley Rural Electric Cooperative, it is indeed our pleasure to report on the status of your cooperative. In this report, we will highlight some of the co-op's achievements during 2010. We hope you feel privileged to be a member and part-owner of this utility, as it continues to hold a strong financial position while providing unsurpassed customer service at reasonable rates.

The co-op maintains a solid percentage of member equity as recommended in our equity management plan. At the end of calendar year 2010, member equity as a percentage of total assets was 41.9 percent.

Last year, nearly \$913,000 in patronage capital was returned to eligible members and former members of the cooperative. The financial stability of the co-op is demonstrated by our ability to retire capital credits while supporting operations and maintaining equity. Nearly \$18 million in capital credits has been given back to consumers over the years and we plan to continue that course into the foreseeable future.

In the area of technology, we finished a complete digital system inventory of all the co-op's power lines and equipment in 2010. We also continued moving toward our goal of upgrading to an automated meter reading -- or AMR -- system. This will enable us to troubleshoot outages more quickly ... and members will no longer have to read their meters. So far, we've activated about 9,000 meters, which is more than 40 percent of all the devices on our system. We anticipate that every member on our lines should have an automated meter activated at their property by the end of 2012.

We also continue to update our load management system, which is used to turn off electric water heaters and other heating and cooling systems during periods of peak demand. The new equipment is allowing us to take advantage of the latest innovations in demand-side management. Demand response is an important resource to use in controlling electric rates because it cuts down on costly demand charges and reduces the need for new generating capacity.

With regard to customer service, the co-op now offers credit card and online bill payment options as well as online access to account history information. In the near future, members will also be able to pay their electric bills via telephone.

As we are sure you're aware, technology continues to play a vital role in our industry. In the early days of the

co-op, we maintained only a few hundred miles of line and served just over 1,000 members. Now we maintain more than 2,900 miles and serve nearly 22,000. Yet we employ only 63 personnel -- roughly the same number of people as we did when we started. Technology helps us keep our workforce lean and save money.

Keeping trees trimmed along Valley's 2,900 miles of electric distribution line is one of our most challenging and costly maintenance programs. More than 413 miles of line were trimmed in 2010 at a cost of \$1.2 million. Valley's five-year right-of-way maintenance cycle helps the co-op minimize costly and inconvenient outages and reduces energy losses, allowing our distribution system to operate more efficiently. In fact, we estimate that this program saves members more than \$350,000 annually in wholesale power costs.

Co-op personnel focused on several system improvement projects in 2010. In fact, more than \$5.6 million was allocated for various work plan obligations.

Last year, 13.8 miles of new distribution line was constructed and 215 new electric services were brought on line.

We upgraded one mile of three-phase underground line on the east feeder of Miller Substation. Plans were made in 2010 to begin upgrading the north feeder of Piney Ridge Substation and the Route 30 Substation; work will begin on those projects this year. We are also upgrading the underground wire in the Maple Hollow and Willowbrook housing developments.

Through innovation and dedication, we are working to control costs and keep your electric bills affordable while providing the best possible quality of service. We will keep putting you, our members, first. And no matter what the future brings, one thing is certain: We're looking out for you.

Home Energy Audits



Members can gain valuable insight into their energy consumption by using the cooperative's free, online, interactive home energy application. It features energy use calculators, a library of energy information and a section for children. Access it by clicking on the "Save Energy" tab at www.valleyrec.com.



The co-op employs a fulltime energy specialist who is available to answer questions about energy use and who also performs inhome energy audits when appropriate.

Energy Management



Water Heater Rebate

A rebate of up to \$3 per gallon is available to members who purchase a new electric water heater. The tank's energy factor must be 0.9 or higher and the member must agree to participate in demand response.

Cooperatives believe that the cleanest kilowatt-hour is the one that is never generated. Holding to this principle, Pennsylvania and New Jersey electric cooperatives launched the Coordinated Load Management System in 1986. This demand response network, whose participants include nearly 25 percent of the cooperatives' residential consumers, currently boasts the capability to reduce about 8 to 10 percent of the entire cooperative system's peak load. Since the program's inception, this has resulted in power cost savings of close to \$90 million statewide for cooperative members.

Members who agree to participate in this worthwhile efficiency program receive a one-time \$25 credit on their electric bill.






Kilowatt-hours sold (in millions)




Utility plant (in millions)



Miles of line




Accounts served (in thousands)
