## New bill dates coming in February

VALLEY REC has always prided itself on its ability to continuously become more efficient. Whether it be by deploying iPads in the field for our linemen to complete work processes or upgrading system resources such as our Outage Management System (OMS) to improve outage restoration times, the co-op is always striving to implement practices that improve operational procedures.

Most recently, your co-op made the decision to make enhancements to its billing cycle. Currently, the billing date for the majority of accounts is the 20th of the month. The new method will disperse the billing dates to either the 15th, 20th, or 25th, depending on your service location and type of account. The list below will provide guidelines on the new billing procedures, which take effect with January's bill — due in February:

- ▶ **Martinsburg service district members** – bills will be mailed out on the 1st and are due back by the 15th of the month.
- ▶ **Huntingdon service district members** – bills will be mailed out on the 5th and are due back by the 20th of the month.
- ▶ **Shade Gap service district members, large commercial and net metering accounts** – bills will be mailed out on the 10th and are due back by the 25th of the month.

The main reason for this modification is to help evenly distribute the billing workflow. This will alleviate

the abundant inflow of bills due back on a single day of the month. Please note these adjustments will not affect your bill amount. The only thing that is changing is the mailing date and the due date.

There are a few advantages these changes will bring for your cooperative. Evenly distributing the billing cycle throughout the month will increase the overall efficiency for the billing department. It will also level out the incoming call volume regarding billing inquiries from members.

Another benefit is that the auto-pay option will become more time conscious. This means that if you need to make changes to your auto-payment option, you can do so up till the day before your bill is due.

If you are not sure which service district you live in, call our office toll-free at 800-432-0680 and one of our customer service representatives will assist you. Otherwise, please make sure to view your January bill, which is due in February, and pay extra attention to when your new due date occurs.

Lastly, keep in mind the several ways offered to you to pay your bill — online through SmartHub, by phone or auto-pay, and by paying at the front desk of either the Martinsburg District, Shade Gap District, or the corporate office. All of these options are provided to you with no additional fees. ## Co-op opens new district office

VALLEY Rural Electric Cooperative recently completed construction of a new district office building that will help improve operational efficiency. The new building will host employees from the Martinsburg District, where they will continue to work for co-op members located within the service territory.

"We are very excited about the new district office because it will allow us to improve operations and better serve members in that area," says Rich Bauer, president & CEO of Valley REC.

Palmer Construction performed the majority of work on the district office. Co-op employees also played role in the building's completion. Wiring, electrical, and data cabling were taken care of largely in part by the Valley REC Energy Services electricians with help from linemen and other co-op personnel. Overall, the joint effort was successful in developing the final product.

"Palmer Construction did a fantastic job," says Bauer. "We are very pleased

with how everything turned out."

Residing east of Martinsburg off Route 164, the new building will replace the previous district office, which is located in town on 721 West Allegheny Street in Martinsburg. Moving out of town was a contributing factor in making the decision to relocate the district.

"The new location will make it much more convenient for line crews to get in and out," says Bauer. "That's one of the benefits of moving out of town."

Plans to build the new district office originated a few years ago when co-op personnel realized the company had outgrown the building and needed more space for the office, warehouse inventory, and a pole yard. The property of the former district office is limited in size. Linemen had to travel about a mile off-site just to get to the district's pole yard, which caused an inconvenience every time repairs and replacement needed to be completed.

"With the need for additional warehouse space, property, and office improvements, it just made more sense to construct a new building that better

suits us for development down the road," says Todd Ross, Valley's vice president of operations. "It will also give us the space we need to complete work more efficiently."

Plans to start the project came to life in August of last year as the final decision was made to go ahead and build the new office. After land was purchased and permits were obtained, the "moving dirt" phase finally began.

Once the process started, it only took a few months for the entire district building to be completed.

"We are thrilled to get everyone situated in the new office to start the new year," says Mike Lansberry, Valley's Martinsburg District manager. "It's an

upgrade we have all been looking forward to for quite some time."

The Martinsburg District will operate out of the old building until Jan. 17. The office will then close the week of Jan. 21-25 for final preparations and will reopen at the new location on Jan. 28.

As for the previous office building, the co-op plans to sell the property, which has an office and two small warehouse buildings.
