Valley offers its take on 'Gone for the Day'

THE LATE Ned Smith (1919-1985), the longtime editor of and contributor to *Pennsylvania Game News* magazine, penned a monthly column called "Gone for the Day." If you followed his outdoor diary — either in its original form in the Pennsylvania Game Commission's monthly publication or in the later, full anthology — you know Ned had a knack for summing up a month's worth of nature observation in a succinct but intriguing opening line.

A typical entry might state October is putting on a brilliant display of color, but a warm spell has deer seeking shade; or that spring peepers are celebrating the March thaw while the skunk cabbage has started poking through the snow.

He would then offer a smattering of observations from several dates that month. It was a practical and enjoyable way to catalog and share information, and worth a try, so here's a Ned Smith-esque offering from Valley Rural Electric:

August brings more electric shifting, trips to two county fairs and a variety of jobs for the co-op's electrical services division.

Aug. 1: It just wouldn't be summer without our Electric Shift radio and TV advertisements. We've run these ads for many years, and maybe by this point in the summer they're getting repetitive, but please keep on shifting when you hear these notices. Use large appliances, such as dishwashers, before 1 p.m. or after 6 p.m. You can also use a microwave or outdoor grill to spare using a conventional oven during these

peak-demand periods. Shifting helps stabilize future power costs.

Aug. 4: The Huntingdon County Fair seems to roll around faster each year. Having a booth in Laney Hall provides us a great opportunity to meet members and answer a wide range of questions. The fair runs through Aug. 10.

Aug. 6: Valley REC is hosting a blood drive on this day in the parking lot of the corporate office. It's open to the public. Stop by and give the gift of life.

Aug. 12 (or any other day): Valley REC Energy Services, the electrical services arm of the co-op, continues to tackle jobs large and small for area residents. Our electricians have been busy with everything from installing water heaters and whole-house standby generators to fixing light switches and upgrading panel boxes. We offer free quotes and prompt service.

Aug. 19: Our annual pole inspection will wrap up at the end of summer. Contracted crews are accessing Valley REC rights-of-way to sound poles with hammers and take core samples. This helps us identify deteriorating poles before they become problematic.

Aug. 25: Our offices are closed after 5:30 p.m. and Fridays - Sundays, but we're always available by calling 800-432-0680.

Aug. 31: If you missed us at the Huntingdon County Fair, Juniata County's event starts this day. Stop by and see us in the commercial exhibitor hall. The fair runs through Sept. 7. It's our last big event of summer. Soon enough we'll be enjoying brilliant fall foliage, and then winter will be here in all her glory. ☀

Valley Rural Electric golf tournament benefits local boy, mother of five in cancer fight

VALLEY Rural Electric Cooperative's 2019 Annual Benefit Golf Outing raised funds for two area families facing cancer and all the challenges the disease entails. The co-op closed its corporate office and all three district offices as employees joined golfers and other supporters for a day at the Huntingdon Country Club with the beneficiaries — Sawyer Werner of Mapleton, a 6-year-old who has been battling kidney cancer; and Heather Irvin of Petersburg, a mother of five, who has been fighting leukemia.

Forty-eight teams registered for the daylong best ball scramble, held June 27. The first flight hit the course at 8 a.m., while the afternoon flight began play at 1 p.m. Valley REC employees share the workload of planning and staffing the yearly tournament and reach-out to local businesses and co-op vendors alike for donations and sponsorships.

"Our benefit tournament brings together golfers and sponsors from across central Pennsylvania and beyond each

year for a good cause," said Valley REC President & CEO Rich Bauer. "We're grateful for all the support this event receives from our vendors, employees and the community."

The cooperative's eighth annual tournament raised approximately \$34,000. The recipients will split the proceeds. The event has raised nearly \$180,000 to date.

"We understand the financial impact cancer can have," Bauer said. "But today is about much more than fundraising; it's about giving the families a memorable day and the camaraderie of everyone coming together for a great cause."

In late May, Sawyer had his 10th and hopefully last chemotherapy treatment. He will need additional scans later this summer. Heather has been in remission since April 10. She was to travel to Pittsburgh in July for additional blood work.

Sawyer, nicknamed "Bean," lives in Cass Township, Huntingdon County, with his parents, Glenn and Megan Werner and younger sisters, Eliza, 3, and Millie, 2. He was midway through

kindergarten when he was diagnosed with Wilms tumor in February 2018. Since then, he has been undergoing chemotherapy and radiation treatments at UPMC Children's Hospital of Pittsburgh.

"It's great to be a part of this," Megan said. "And for the community to come together like this is awesome. Sawyer loved it. He was having fun riding around in a golf cart."

Sawyer is going into second grade at Spring Farms Elementary but has not been able to attend regular classes since kindergarten. It's possible he will resume normal classes by October. Megan works as a substitute elementary school teacher for the Southern Huntingdon County School District and is Sawyer's homebound instructor.

Glenn is a forest and wildlife manager at Raystown Lake and also does logging work. The family has insurance, but as other families in this situation know all too well, other expenses such as gas, meals, and hotel stays add up.

Heather and her husband, Wayne,

Valley REC sponsors area students on Youth Tour to Washington, D.C.

VALLEY Rural Electric Cooperative sponsored 15 high school students from eight school districts on the 2019 Rural Electric Youth Tour to Washington, D.C., June 16-21. The teens spent their time in the capital meeting legislators, learning about the cooperative business model, and touring monuments and memorials.

They joined more than 1,800 other juniors from electric cooperatives all over the country. Of that number, 116 are from the 13 co-ops in Pennsylvania and one in New Jersey that comprise the Pennsylvania Rural Electric Association.

The all-expenses-paid trip is packed with activities, including meetings with rural electric leaders, visits to historic sites, and tours of the Smithsonian museums, Holocaust Museum, National Zoo, and Arlington Cemetery.

Recommended by guidance counselors at their respective schools, the students were selected for the trip on the basis of academic achievement, leadership in extracurricular activities and community service.

Altoona High School had one student on the trip. Corey Lion is the son of Teri Lion and the late Christopher Lion of Altoona. He participates in chorus and drama clubs and serves as treasurer for Blair County Young Republicans. Corey hopes to pursue a career in politics.

One Claysburg-Kimmel High School student, Mackenzie Clemens, participated. She is the daughter of Adam and Kimberly Clemens of Claysburg.

"My favorite part was meeting people from all across the country, meeting people from Missouri, Kentucky, and Tennessee and getting to talk to them and learning more about what they do and how amazing D.C. is to them because they're so far away," Mackenzie said. know about frequent hospital stays and associated expenses. Heather's fight against acute myeloid leukemia has included chemotherapy treatments and multiple bone marrow biopsies at UPMC Shadyside, a hospital in Pittsburgh, since her diagnosis last August.

"This is a wonderful event. We can't thank everyone enough for the support," Heather said during the tournament. "I'm clear right now. It feels like it took forever, but we made it."

The couple resides in Oneida Township, Huntingdon County, with their five children – Reagen, 11; Brianna, 11; Kyara, 10; Bentley, 7; Ryker, 4.

They, too, have insurance, but it doesn't cover everything. Heather had worked as a janitor in the summers at Raystown Lake and did babysitting in her home during the school year. She had to give up her last couple weeks of work at the lake last summer due to her illness. Wayne works as a milling equipment operator for Glenn O. Hawbaker, Inc. in State College.

A committee comprised of employees from the co-op's corporate and district offices selects tournament beneficiaries

each year and plans the golf outing. Previous tournaments have benefited two high school classmates battling cancer; an adult who sustained serious injuries in a car accident; infants and

toddlers with congenital conditions; a high school senior with a life-altering digestive disorder; and a recent college graduate paralyzed in a swimming accident. ☀
