

Why put power lines in harm's way?

HIGH WINDS OR ICY CONDITIONS

are recipes for disaster when it comes to electric reliability because they cause tree limbs to fall on power lines, triggering outages.

Although Valley's line personnel are on call around the clock and respond quickly to problems, some folks have asked us: Why build power lines in harm's way?

One of two methods are used to deliver electricity to a home: Overhead or underground power lines. Although underground lines may seem attractive during storms since the lines are not exposed to extreme weather, the technology doesn't always make sense from an affordability standpoint.

For example, installing power lines underground can cost up to double the amount per foot compared to overhead. It depends on the terrain.

In the United States, most underground lines are found in subdivisions where developers request and pay for the option for aesthetic reasons or to comply with local statutes. A high concentration of homes in these areas helps spread out the expense. According to Hi-Line Engineering, a Georgia-based utility consulting firm, nine out of 10 new subdivisions are served by underground wires.

But the bulk of our country's cooperative power continues to be delivered via overhead lines. Only 16 percent of the 2.5 million miles of distribution lines owned and maintained by electric co-ops across the nation are found underground (although the amount grows by about 1 percent annually).

Because Valley is a not-for-profit organization, we select our distribution methods with two goals in mind: Keeping electricity affordable and reliable for our consumers.

As with most things, there are pros and cons to both forms of power distribution. For instance, underground facilities are more reliable during storms and generally require less right-of-way maintenance because there are no trees, brush and other vegetation to clear away.

However, faults in underground power lines are not easy to track down and fix. A North Carolina study found that outage restoration times averaged 92 minutes for overhead lines versus 145 minutes for under-

ground lines. In 2005 in Virginia, Hi-Line Engineering compared the increased cost of underground lines against their benefits. The results: Underground savings did not outweigh the heavy initial cost of installation.

Obviously, if a tree falls on a line, our crews can often spot the problem right away and get to work restoring power. The same holds true for repairing broken insulators and crossarms -- If you can see it right away, you can fix it right away. But underground lines are tough to troubleshoot. You have to track down the problem based on where the power flow stops. Then a line crew has to dig a hole to reach the spot before repairs can be made.

For most Valley consumers, affordable overhead lines will remain the norm, at least for now. But we will continue to weigh our options, ensuring we always offer the best service reliability at the lowest possible cost. Statistics courtesy of the National Rural Electric Cooperative Association

AT A GLANCE

America's Cooperative Electric Utilities

ELECTRIC CO-OPS are an integral part of the \$344 billion U.S. electric utility industry. They play a critical role in our nation's economy and in local communities.

Electric cooperatives are:

- private, independent utility businesses
- owned by the consumers they serve
- incorporated under the laws of the states in which they operate
- established to provide at-cost electric service
- governed by a board of directors elected from the membership, which sets policies and procedures that are implemented by the cooperatives' professional staff.


Compared with other electric utilities:

- Co-ops serve an average of seven consumers per mile of line and collect annual revenue of approximately \$10,565 per mile of line.
- Investor-owned utilities average 35 customers per mile of line and collect \$62,665 per mile of line.
- Publicly owned utilities, or municipals, average 46.6 consumers and collect \$86,302 per mile of line.



Cooperative's new wellness program focuses on health, community service

WITH THE SUPPORT of the board and management, employees at Valley REC recently kicked off a wellness program aimed at enhancing the health and well-being of co-op personnel, their families and the community.

Objectives of the new program include:

- Offering services and hosting events that emphasize health awareness, prevention and positive behavior change;
- Providing current and accurate information on personal, family and community health issues;
- Fostering a workplace environment that supports a healthy lifestyle;
- Equipping co-op employees and their families with the knowledge and skills necessary to improve and maintain their health and quality of life; and
- ▶ Encouraging and offering opportunities for community service.

To help steer the new program and organize events, a health and wellness committee, comprised of employees from all three co-op districts and the corporate office, was formed.

"Joining the (health and wellness) committee has given me the opportunity to expand my skills beyond my typical work

duties," said co-op Executive Secretary Kim Kane. "Plus I am always looking for ways to improve my own health and this program has been a great source of accountability for me and my family."

The committee was charged with the planning and execution of events that align with the mission of the new health and wellness program.

The committee hit the ground ... walking ... in March. They organized a co-op-sponsored walkathon where Valley employees and their family members helped to raise \$1,300 for Huntingdon County PRIDE, Inc.

In May, a Rails-to-Trails bike ride brought co-op families together for a day of fun.

In June, Valley hosted a horseshoe tournament, raising more than \$300 for a local Lions Club.

In July, co-op personnel and their families organized and participated in a softball tournament, raising nearly \$1,500 that benefitted a local girl with disabilities.

To help propel the program forward and explore other avenues, the health and

wellness committee recently called on the expertise of Jennifer Reese, a certified wellness program coordinator with Highmark Blue Cross Blue Shield, the co-op's insurance provider for employees.

Jennifer explained that, by using Highmark's preventive health services, the co-op could take advantage of many resources such as tobacco cessation programs, health screenings and assessments, physical activity challenges, nutrition, health and weight management programs and behavioral health and stress management programs.

"Statistically, we know that workplace wellness works," Jennifer pointed out.

In addition to boosting morale and productivity, workplace health and wellness programs have the potential to substantially decrease healthcare premiums, she said.

"It's a win-win situation for everyone," she added.

Upcoming co-op health and wellness events include a scavenger hunt, blood drive and health risk and productivity assessment.

Extend a helping hand to needy neighbors

AS THE HOT, humid days of summer wind down, many of us here in Pennsylvania grow eager to experience that first chilly autumn breeze and to take in the bright fall foliage.

For a lot of co-op members, however, that chill in the air isn't a source of excitement, but rather of fear about how they will pay for the coming winter utility bills.

You can help these needy families by donating to Valley REC's Members Helping Members assistance program.

A choice of several billing options makes giving easy, and all donations are tax-deductible.

If you'd like, you can round up your bill to the nearest whole dollar, with the difference earmarked for needy members. For example, if your monthly charges total \$86.32, you could choose to round up the amount to \$87, with 68 cents going to Members Helping Members. Using this method, your average annual contribution would be about \$6.

If you'd prefer, you can simply add \$1 to the total due on your bill, for an annual contribution of \$12. Actually, any amount you wish may be added to your bill. Or you can also opt for a one-time donation.
