Executive Report

On behalf of the board of directors and employees of Valley Rural Electric Cooperative, it's our pleasure to report on the status of your electric distribution business. We hope you find this annual report informative and see that your cooperative remains ready to provide safe, affordable and reliable power to our consumers.

The cooperative remains on sound financial footing. At the end of 2024, equity, or member ownership of the organization, was at 51.9 percent of assets, which is in line with our equity management plan. We returned more than \$2.6 million in patronage capital to eligible members and former members in December 2024, which follows the December 2023 return of \$2.3 million. Over the years, we have returned nearly \$41 million in patronage capital.

The co-op's largest outlay is to Allegheny Electric Cooperative for the purchase of electricity. In 2024 the co-op spent more than \$22 million for power, about 51 percent of the 2024 budget. Valley REC was in the fortunate position of not having to implement a rate adjustment for 2024, and rates remained unchanged going into 2025.

Valley REC and its 12 sister cooperatives in Pennsylvania, and one in New Jersey, own approximately 65 percent of our energy supply. The remaining 35 percent must be purchased on the open market where prices are much more volatile. We continue to ask our members to lend a hand in stabilizing future wholesale power costs by shifting summertime use to early mornings and evenings and participating in our demand response program. If you're already enrolled in the program, thank you. If not, please take a moment to review the load management information on the next page or contact the co-op.

Improving system reliability and power quality is an ongoing process at Valley REC. In 2024 we built a new Three Springs substation at the site of the previous facility. This effort marked Valley's fifth substation construction project since 2016 and replacement of the final 1950s-era substation still in operation on Valley REC's system, which includes 23 subs. Moving forward, we will be rebuilding the 46kV delivery point at the Puzzletown substation in western Blair County. The project entails replacing an aging substation recloser with a newer, more advanced breaker. Additionally, the co-op's operations personnel will continue work across the system to replace aging aluminum-steel wire with all aluminum wire which is more corrosion resistant. Replacement of deteriorating poles identified during inspection will be ongoing as well.

Additionally, we are continuing our aggressive approach to vegetation management. In 2024 we trimmed 448 miles of rights-of-way. Our approach ensures our rights-of-way are trimmed entirely in a five-year time span to lessen the likelihood of tree-related outages. We believe right-of-way clearing has been a major contributor to our reliability statistics. Last year we averaged one outage per year per member. We're pretty proud of that considering the terrain we serve.

Following the co-op principle of Cooperation Among Cooperatives, we sent four of our line workers to North Carolina in October to help restore power after devastating hurricanes in the South. We also sent a crew to a sister Pennsylvania co-op, Claverack Rural Electric Cooperative, to help restore power after a severe July thunderstorm.

Following the co-op principles of Continuing Education and Concern for Community, we continue to offer safety and energy efficiency presentations to schools and civic groups. We invite you to contact the co-op for more information on these programs.

And we invite you to contact the co-op offices with any general questions you might have. Be assured, the dedicated employees and board members of Valley Rural Electric Cooperative are working diligently to improve efficiency and control costs. Providing safe, affordable and reliable power has been our mission since 1938. We look forward to building on that legacy.

Products, Programs and Services

Load Management

Co-op members who participate in the demand response program help lessen the impact of volatile wholesale market pricing. More than 5,500 Valley REC members are already on this program in which a remotely operable switch is installed on the electric supply line of their storage tank water heater. Temporarily shutting off water heaters during periods of peak demand helps lessen future generation costs to the co-op.



Participants receive a

\$100 bill credit and are also eligible for rebates on the purchase of new water heaters.

If you're already participating, we'd like to say thank you for doing your part over the years. If you're not on the program, please consider joining. Control periods should not inconvenience you, and you'll be helping to keep our costs in check as much as possible.

Community Service Grant Program

Valley Rural Electric Cooperative debuted its Community Service Grant Program at the 2015 annual



meeting and has since awarded more than \$350,000 in funding. This initiative offers grants to co-op members experiencing financial hardship, to service organizations such as fire and ambulance companies and to educators who need support materials to teach blocks of instruction related to electricity or the cooperative business model.

Individuals or groups filling out applications will select one of three categories: energy assistance, education or civic/ community programs. Grants of \$500 to \$1,000 are available.

The initiative is funded through unclaimed capital credits – margins that can't be returned to members and former members due to death or relocation.

Co-op Connections Card

Valley REC members can take advantage of the Co-op Connections Card program. The card offers discounts from businesses in our communities and across the country. Discounts of 10-85 percent are available

on prescriptions at participating pharmacies. The average discount for our members is 50 percent. Show the card and save the next time you're shopping. For a full list of participating businesses, go online and visit valleyrec.com.

Scholarships



Valley REC awards up to 30 \$1,000 scholarships each year to eligible students who apply for the Brighter Future Scholarship Program. High school seniors who are dependents of co-op members and are either enrolled in public, private or cyber school or are home schooled are welcome to apply. This initiative is funded by unclaimed capital credits refunds that previously had to be turned over to the state treasury. Thanks to the efforts of the co-op's political advocates, these funds can now be kept in our local communities. The Pennsylvania Rural Electric Association offers two different scholarship programs as well.

Safety and education programs

Valley REC offers education programs to students and civic groups within the co-op's service territory. Presentations focus on electrical safety, energy efficiency and co-op careers. For more information contact our Member Services department.



SmartHub

Valley REC offers the SmartHub[®] online payment service, which allows members to sign up for electric service, access account history and pay electric bills online. Members can use the service to

have the amount of their monthly electric bills deducted automatically from a checking or savings account or credit card. SmartHub also enables members to receive alerts using their mobile devices. Click or tap the "View & Pay Bill -SmartHub" tab on the website. Members may also pay by phone (using a credit/debit card or check) and at co-op offices.





Valley Rural Electric Cooperative, Huntingdon, was set in motion by a group of determined farmers around Martinsburg in southeastern Blair County. The cooperative was incorporated on Nov. 1, 1938 and received its first Ioan in March 1939. Under the first manager, Floyd Bush, the first 250 miles of line were built, and a substation was constructed at Williamsburg. Lines were first energized on Nov. 17, 1939.
