We want to stay in touch, just enough

LIFE is full of fine lines: between genius and insanity and between confidence and arrogance. Comedian Steven Wright used to say there's a fine line between fishing and standing on the shore looking like an idiot.

And there's probably a fine line between communicating effectively and hounding someone, too. At Valley Rural Electric, we always want to be on the right side of that line. We want to keep in touch, but just enough.

To most effectively communicate with our members, we rely on you to make sure we have your most accurate contact information. Up-to-date contact information is critical. It can even speed up the power restoration process during an outage. For example, the phone number you provide is linked to your service address in our outage management system. This means when you call to report an outage, our system recognizes your number and matches it with your address. Accurate information makes it easier for our crews to find and correct service disruptions.

Many of you have been members of the co-op for years, and it's likely that your information hasn't been updated for some time. Many members now

use a cellphone as their primary phone service, and we might not have that number in our system.

We call members directly about payments or changes to accounts. So, having a good contact number is important. However, we never ask for personal information over the phone. If you receive a suspicious call, hang up and then contact us at 800-432-0680.

We will never share your contact information with any third parties. It is only used by us to send important information to you. And we only use automated calls to share information we assume members would want to know. There's a saying that assuming too much is foolish, but we think members appreciate automated calls about planned outages or reminders if you have registered to attend a district nominating meeting. Because the meeting includes a homestyle supper we think most folks appreciate that automated reminder, because of another saying — "Free meal, spin the wheel."

If you're not sure we have your most up-to-date contact information, please contact us and we'll update our records. We're always glad to hear from you and we want to be able to reach you when you need to hear from us.

Districts 1, 3 & 5 hold nominating meetings

IN FEBRUARY, Valley REC held nominating meetings in co-op Districts 1, 3 and 5. The nominees shown on the following page were selected to stand for election to the co-op board of directors at the annual meeting to be held Friday, April 3, at Huntingdon Area High School.

Nominating meetings are held each year in three of the co-op's nine director districts. This year's meetings were held at Morrison's Cove Memorial Park, Blair County (District 1); Marklesburg Volunteer Fire Company (District 3); and Shavers Creek Volunteer Fire Company (District 5), both in Huntingdon County. After a home-style meal, members heard an update from VREC President & CEO Rich Bauer. Members then had the opportunity to participate in a question-and-answer session.

"We had a good year in 2019. When we got near the end of the year, we started to notice that our power costs were coming in lower than anticipated," Bauer said. "They ended up \$1.1 million lower than expected."

He explained that the \$1.1 million windfall spurred the decision by the board of directors to reduce the kilowatt-hour rate for November by half. That savings was reflected on December's bills, which also reflected a \$2.3 million capital credits return.

Bauer said several factors contributed to the banner year. The Susquehanna Steam Electric Station — a nuclear plant in Berwick, Pa., that provides Valley REC with 60% of its wholesale power — operated with just 16 down days in 2019.

Mild weather also helped. And members used power efficiently by operating ovens, dryers and swimming pool pumps in the early mornings or evenings — or by participating in the co-op's demand response program. The program centers around a water heater switch that temporarily cuts power

to electric storage tank water heaters during peak load periods.

Bauer explained that part of the co-op's power bill is comprised of capacity charges driven by peak load periods. Kilowatt-hour rates can skyrocket during these periods.

"I don't want to sell you expensive power," Bauer told members.

He reported that the co-op trimmed 500 miles of rights-of-way in 2019. He thanked members for their cooperation as trimming crews accessed rights-of-way.

He also reported that in 2019 the Community Service Grant Program handed out \$61,000 in assistance to civic projects and to members struggling with bill payment due to hardships. The grant program is funded through unclaimed capital credits returns.

Bauer updated members on substation improvements planned for this year and 2021. The co-op is currently re-replacing the aging Metal Substation, in Metal Township, Franklin County, with the new Path Valley Substation. The project will increase reliability by decreasing the likelihood of a loss of power supply by the private power company that serves the substation.

Valley REC had a record 53 outages in 2019 that were caused by loss of power to the co-op's substations.

This summer, Valley will replace the Atkinson Mills Substation in Wayne Township, Mifflin County. The old wooden structure will be replaced with an all metal structure. In 2021, the Sinking Valley Substation in Tyrone Township, Blair County, will be replaced.

Questions from members ranged from the economics of home solar ar-

He is a 1979 graduate of Huntingdon Area High School, a past member of the National Holstein Association and a member of the Pennsylvania Farm Bureau. He was formerly involved with the Huntingdon County 4-H dairy and beef clubs and was a member of the Rural Electric Youth Tour delegation in 1978.

Members were given a jute shopping bag as a token of appreciation for their attendance. Three members at each location also won a \$50 bill credit. ☀


